## Withdrawal of Learning

Pupils are **only** in school for 190 days each year.

There are 175 other days for holidays and other activities 80% attendance represents 1 day off a week. 90% attendance represents 1 day off per fortnight



## How to use this form:

- Use for all absence other than sickness
- Return to school **BEFORE** the date of requested absence.

## Guidance:

The Government and West Sussex Policy now state that Head Teachers may not grant any leave of absence during term time, unless there are <u>exceptional circumstances</u>. There is no entitlement to take a child out of school for a family holiday. These amendments came into force on 1<sup>st</sup> September 2016. We are still part of the Fixed Penalty Scheme in West Sussex. Further information can be found in school or at West Sussex County Council website.
